



## COOKIES POLICY

### 1. Why is a cookie policy necessary ?

Your privacy is a priority for FEBIAC (hereinafter "FEBIAC", "we" or "us"). In this respect, we are committed to protecting the personal data of our online users (hereinafter "you") collected through cookies, tags, tracers (hereinafter generally: "cookies") and treating it with the utmost care, in accordance with the legal provisions in force and specifically the Act of 13 June 2005 on electronic communications.

### 2. Who has control of your personal data ?

### 3. Which cookies do we use and for what purposes ?

Cookies are text files that contain certain information that is downloaded to your device when you visit a website. The cookies are then sent back to the original website at each subsequent visit, or during a visit to a site that recognizes this cookie. They are useful because they allow a website to recognize a user's device and often facilitate the user experience.

Cookies perform multiple functions, such as allowing you to navigate between pages efficiently, remembering your preferences, and generally improving the user experience. They can also help to ensure that the ads you see on a site are more interesting for you, based on your interests.

On our website, we use both essential and non-essential cookies :

- Essential cookies : These are cookies that are necessary for technical reasons for the functioning of our website. They allow you to browse our website and use the main features of our site. The goal here is to send a communication via an electronic communications network in accordance with Article 129 of the Act of 13 June 2005 on electronic communications, and your consent is not required to activate these cookies.
- Non-essential cookies : These are cookies that allow you to personalize your user experience on our website, but which are not essential to its operation. These cookies cannot be used without your prior consent and are therefore the subject of the request sent to you during the first visit of our site (please note that our cookie management tool allows you to change your preferences at any time, and that you can configure your browser to disable or delete cookies).

These non-essential cookies perform several functions, and we can distinguish between :

- **Functional cookies :** Functional cookies allow us to personalize your experience on our site (for example, these cookies record your language). They also allow the use of certain features like content sharing on social networks.
- **Analytics cookies :** These cookies collect information about how you use our website (for example which pages you look at most often, or how long you stay on our website), mainly in order to improve its functionality (for example, to resolve error messages on some pages of our site) and help us understand which pages and sections are most successful.
- **Targeted advertising cookies:** We and our advertisers may use cookies to provide you with ads we think are relevant to you, based on your interests. You may see these ads on other websites you visit.

Cookies can vary depending on their validity period on the user's device :

- **Persistent or permanent cookies** remain after the session has ended. They are stored until they expire or until the user deletes the cookies.
- **Session cookies** only last for the duration of the visit on a website (session), and they are erased when the user closes the browser.

Cookies can also differ depending on the origin of their placement :

- **First-party cookies** belong to our site and the information collected via these cookies is entirely under our control. No data is sent to third parties, and we can therefore guarantee that this information will not be used for any other purpose.
- **Third-party cookies:** are cookies linked to the activity of third parties. They are imported from a site whose content is indirectly accessible, for example via an image or a banner. FEBIAC is not responsible for the content of these third-party cookies and the content of their privacy policies.

In the cookie management tool on the website (tab « Details »), you can find the complete list of cookies (classified by category), including a link to the third parties to allow you to view their statements and manage your consent to each third-party cookie.

## 4. How to manage the deposit of cookies ?

If you wish to allow, refuse, or delete cookies stored on your computer, simply disable cookies in the relevant category using the cookie management tool on our website. However, refusing a cookie or categories of cookies does not delete cookies from your browser.

If you want to know which cookies are installed on your device or if you wish to delete them, you can use a setting in your browser. To do this, follow the instructions provided by your browser, as these may vary from one browser to another. Generally, to delete cookies, you will need to select the "Settings," "Tools," or "Options" menu in your browser, and then go to the Privacy or History section.

If you choose to disable cookies, be aware that you will not be able to take full advantage of certain features on our website and the FEBIAC user experience.
